Pupil Premium/ Free School Meals (Key- Stage 2)

If your child is in Key-Stage 2 and you meet the criteria listed below, then a hot lunch is provided free of charge to your child each day as well as the school receiving funding of £1300 called Pupil Premium to further support their learning.

Who is eligible for free school meals?

Free school meals are available to pupils in receipt of, or whose parents are in receipt of, one or more of the following benefits:

- Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax

Credit and have an annual gross income of no more than £16,190)

• Working Tax Credit run-on – paid for four weeks after you stop qualifying for Working Tax Credit.

Please note that families with children in Key-Stage 1 can apply for Pupil Premium so that we will receive additional money to support their learning.
